VV has been conducting training for the UN, AU and EU in connection with her work for The Folke Bernadotte Academy under the Swedish Ministry of Foreign Affairs where she from 2005-2008 was member of the task force for mediation and dialogue. VV has worked as a international trainer, teacher and mediator in e.g. Serbia, Montenegro, Bosnia, Albania, South-Africa, where she has worked with politicians, NGO- persons and researchers (1995- 2005). She has trained (90%) of the judges involved in the Danish Court Annexed Mediation Program (launched in 2004). Has planned and taught courses on Negotiation, Dispute Resolution and Reconciliation for International Humanitarian preparedness (IHB), Danish Ministry of Foreign Affairs (2002-04). Since 1997 she has been member of the Law and Justice Danida program for Judges from the 3. world.

She has run courses at University of Cape Town, South Africa (2002), Belgrade University, Serbia (1998), Nuuk University, Greenland (1998), Mondlane University, Maputo, Mozambique (1995), University of Witwatersrand, Johannesburg, South Africa (1995) and Kyoto University, Japan (1989) and has had presentations on numerous international conferences e.g New York, 2006, Helsingfors 2006, den Haag, 2006, Sevilla 2005, Sydney 2002, Washington 2001, Tokyo 1997 + 1995, St. Petersburg 1996 etc.
