1. Brief introduction of the Institute

The Wangari Maathai Institute for Peace and Environmental Studies (WMI) was established in 2009 as a centre of excellence in environmental governance and its linkages with peace and democracy. The Institute was established in close collaboration with the 2004 Nobel Peace Prize Laureate, the late Prof. Wangari Maathai. WMI aims to promote good environmental practices and to cultivate a culture of peace by shaping values, ethics and attitudes of its graduates through experiential learning, mentoring and transformational leadership.

6. Research and training activities undertaken

i) Sustainable Land Use and Natural Resource Management (SLUSE 2019)

The Wangari Maathai Institute for Peace and Environmental Studies in collaboration with the University of Copenhagen and Roskilde University, Denmark successfully implemented the 2019 experiential field learning course dubbed, "**Sustainable Land Use and Natural Resource Management – (SLUSE)**," which is the 7th in a series after the SLUSE courses in 2012, 2014, 2015, 2016, 2017 and 2018. The program was held in Kibugu, Embu County, from March 1-12, 2019. It incorporated students from various disciplines including environmental governance, agriculture, sociology, anthropology, economics, forestry, livestock production and law. The course was attended by thirty five (35) students of whom seventeen (17) were international students from both University of Copenhagen and Roskilde University and eighteen (18) from the University of Nairobi-Wangari Maathai Institute and the Department of Geography and Environmental Studies.

7. International linkages and Collaborations

The symposium brought together a wide range of participants (local, regional and international) including the Institute for Global Environmental Strategies (IGES) Japan, Education for Sustainable Development in Africa (ESDA) and the Ministry of Education, Kenya.





iii) The Wangari Maathai Institute hosts the closing ceremony for the SLUSE 2019 course - Tuesday 12th March, 2019 The Wangari Maathai Institute for Peace and Environmental Studies' joint Sustainable Land Use Management (SLUSE) programme with the University of Copenhagen was successfully concluded by a colourful closing ceremony that was held on March 12, 2019 at the WMI green



campus. This event saw the award of certificates to the 35 participants after successful completion of the experiential learning course on Sustainable Land Use Management Systems (SLUSE) in Kibugu, Embu County. The students are expected to write examinable reports and also publish their research findings to contribute to the much needed scientific evidence. Challenge(s)

i) In 2012, the Institute received funding from the African Development Bank and the Government of Kenya to support the design process and the construction of the first phase of the WMI Campus. This was made possible through a project entitled, "Support for the Enhancement of Quality and Relevance in Higher Education Science and Technology in Selected Universities in Kenya Project." The construction of the 1st phase of the Campus is now complete except for the furniture which, if provided, will facilitate the full operationalization of the Institute.

ii) Strategic Projections

With the completion of the first phase of the WMI Campus, we plan to progressively implement the activities in the Strategic Plan including full development of the experiential learning platforms. The Institute has adequate facilities to host conferences and symposia both local and international. With adequate space, facilities and revitalized training and research agenda, we also hope to attract more international students and faculty. Together with the stakeholders, we will operationalize the Peace Labs so that the Institute becomes a focal point for mediation and training in conflict resolution.

14. Any other activities

(i). Seminars/Workshops

In 2019, the Institute organized/co-hosted the following seminars/workshops:

- i) The Wangari Maathai Institute (WMI) hosted a seminar on the "Future of Forests; REDD+ Readiness" on November 27, 2019. The seminar was delivered by Prof. Nzioka J. Muthama, Deputy director, WMI, Dr. Jane Mutune and Dr. Bessy Kathambi and attracted a wide range of participants including students, staff, policy experts and practitioners among others. The seminar introduced participants to the REDD+ process in Kenya and where the country is regarding the implementation of REDD+.
- ii) NACOSTI Chief Science Analyst Margaret Maimba shared insights on the role of NACOSTI in formulation and implementation of public policies with staff, students, policy experts and practitioners at the Wangari Maathai Institute on Wednesday November 13, 2019.
- iii) On September 27, 2019 the Pan-African Climate Justice Alliance (PACJA) held the climate change march which marked the climax of the Global Climate Week. The walk was organized in partnership with OXFAM, 350.ORG, the Kenya Platform for Climate Governance, Christian Aid among others. Mr. Charles Mwangi, the Thematic Leader for Resilient Economies, Societies and People led the walk.
- iv) The Institute co-hosted the Food Security Center Regional Workshop. The event was organized by the University of Nairobi team in collaboration with the Food Security Centre and a consortium of local and regional Universities. The workshop was held from September 23-25, 2019 under theme, "Sustainable Safe Food Systems in Africa: Moving towards a Sustainable Food Future." The workshop brought together participants from all over the region with the aim of discussing issues surrounding the safety of food for consumption.
- v) WMI co-hosted the 2nd Kenya Organic Food Festival and Exhibition (KOFFE) from September 20-21, 2019. This important event was officiated by Prof. Rose Nyikal, Ag. Principal, College of Agriculture and Veterinary Sciences who in her remarks, acknowledged the efforts of disseminating crucial information about healthy and organic food. Professor David Mungai, Director WMI welcomed the stakeholders and gave a brief overview of the Institute. He also pointed out that WMI is currently working towards establishment of an organic and herb garden that is meant to educate and benefit the community.
- vi) On 13th August 2019 WMI organised a youth capacity building workshop to mark the international day of the Youth. The workshop involved expert presentation on Apiculture, Briquette-making, mindset change.
